Educational Qualifications:

- Bachelor's degree in statistics/social sciences/any other discipline. Preference will be given to the candidates having degree in statistics/social sciences.
- or
- Diploma in Agriculture. Candidates having PG Diploma in sustainable agricultural development are desired.

Desirable:

- Working knowledge of computers.
- Experience in field data collection, analysis and working in FLDs related projects.
- The candidate should be able to read, write and speak in Telugu and English.

Remuneration:

- Rs. 30,000/- per month consolidated.
- It is purely contractual appointment for a specific period up to 31.03.2026 and co-terminus with the FLD project or even before at the discretion of the Competent Authority.

Age Limit:

- Minimum of 21 years and maximum of 45 years as on the date of interview i.e 12.08.2025. Relaxation in upper age limit is permissible in case of SC/ST/OBC/PH candidates as per Govt. of India rules applicable to the ICAR.

Place of posting:

- The initial place of posting would be ICAR-IIOR, Hyderabad but can be placed anywhere in India based on requirement.

Terms and conditions:-

1. The above engagement is temporary/ contractual and carries no other allowances. Total engagement will be for maximum three years (extendable for 01 year at a time). The YP I will have no right to claim any employment or engagement in ICAR-IIOR.
2. The interview will be held only if atleast five applicants appear for the interview. In case the number of candidates exceed 20, a screening test may be conducted and only shortlisted candidates may be allowed to appear for the interview.
3. Since the above positions do not have status of regular employees they are not entitled for any regular leave except 8 days CL and 2 days RH, mandatory/ paternity leave as applicable.
