Eligible candidates are invited to attend a Walk-in-interview to fill up the purely temporary post of **Junior Research Fellow (One no.)** consolidated pay of Rs. 37,000.00 per month + HRA under "Central Sector Scheme for Protection of Plant Varieties and Farmers Rights Authority (PPV&FRA) sponsored Project titled "DUS testing of Sunflower, Safflower and Castor" to be held on 18<sup>th</sup> December at 11:00 AM at the ICAR-Indian Institute of Oilseeds Research, Rajendranagar, Hyderabad - 500030.

#### **Essential Qualifications:**

M.Sc. (Agriculture) with specialization in Plant Genetics/ Plant Breeding/ Seed Technology/ Agronomy or any other relevant discipline in Agricultural Sciences with 4 years/ 5 years of Bachelor's Degree.

Candidates having 3 years Bachelor's degree should have NET qualifications

#### Desirable qualifications:

• Experience in field work, Qualitative and Quantitative data recording, along with working knowledge of computers

#### Age Limit:

 Minimum of 21 years and maximum of 35 years for Men and 40 years for women as on last date of application i.e 18.12.2025. Relaxation in upper age limit is permissible in case of SC/ST/OBC/PH candidates as per Govt. of India rules applicable to the ICAR funded project.

#### Terms and conditions:-

- 1. The above position is purely on a contractual basis, time-bound, non regular and co-terminus with the project. The initial engagement of the JRF will be till 31st March 2026 until further orders subject to requirement of the services of the JRF and satisfactory performance of the candidate after evaluation. The selected candidate shall not claim for regular appointment at this Institute after termination of the project.
- 2. The interview will be held only if atleast five applicants appear for the interview. If the number of candidates reporting on the scheduled interview date exceeds twenty (20), a written test may be conducted as part of the selection process. Based on the performance in the written test, shortlisted candidates will be called for the interview on the same day.
- 3. No TA/DA or stay will be provided for appearing in the Walk in Interview. After selection, candidates have to make their own arrangements for accommodation to stay at the place of work.
- 4. The initial place of posting would be ICAR-IIOR, Hyderabad but can be placed anywhere in India based on requirement of the project.
- 5. Candidates are requested to carry all original relevant documents/caste certificates if applicable along with a set of attested XEROX copies, photograph and duly filled in application form on the date of interview. They may attend the interview only if they fulfil the essential qualifications. Only relevant experience if any will be considered on producing the experience certificate. NOC from the previous employer should be produced if still working.
- 6. Candidates have to report by 9:30 A.M. and register their candidature till 10.30 A.M. on 18.12.2025.
- 7. The decision of the Director, IIOR, Hyderabad will be final and binding in all aspects.
