WALK IN INTERVIEW

Eligible candidates are invited to attend a Walk-in-interview to fill up the temporary post of Part-time Medical Officer (PTMO) purely on contractual basis to be held on 29th December, 2025 at 11:00 AM at ICAR- Indian Institute of Oilseeds Research, Rajendranagar, Hyderabad - 500 030 (Telangana). The eligibility criteria and terms & conditions as prescribed for the purpose are as under.

Name of the post	Eligibility Criteria
Part-time Medical Office (PTMO)	Qualifications MBBS or equivalent degree from a recognized university, institution and should be registered with the National Medical Commission (NMC)/ State Medical Council, other statutory body as per legal requirement for practicing medical treatment.
	Preference may be given to candidates with a minimum of 05 years of relevant experience in a Government Autonomous/ Private hospital setup
	 Age Limit Maximum of 65 years as on 29.12.2025, relaxable in exceptional cases on case to case basis. However, no engagement shall be permissible beyond 70 years under any circumstances
	 Remuneration Consolidated 40,000/-(Rupees Forty Thousand Only) permonth (all inclusive) Subject to annual revision of not more than 5% on the base value after each completed year of engagement for upto 03 years maximum. If, the same PTMO is engaged by two or more institute that are situated within a radius of 3kms, the PTMO sho be entitled to receive full remuneration from the institute who has engaged him first, and 50% of the prescriber remuneration from each additional institute a subsequent engagement. Subject to deduction of TDS as applicable under the relevant provision of Income Tax Act.

Terms & Conditions:

Nature, duration and termination of engagement:	 Purely on a part-time and contractual basis. It shall not confer any right for regular appointment or continuity in service. Initially will be for a period of one year, which may be extended based on performance and requirement, subject to approval by the competent Authority. However, no engagement to be continued beyond a period of three (03) years in total. Either party may terminate the engagement by giving one month notice or one month remuneration in lieu thereof.
Working hours and attendance record:	 Minimum 02 hours per day and minimum 03 days in a week or as mutually agreed upon for longer periods and duration. The present timings of ICAR-IIOR are 9:00 AM to 5:30 PM with lunch breaks from 1:00 PM to 1:30 PM (Saturday and Sunday closed holidays). Attendance will be maintained by the Institute and payment shall be made only for the days attended. Monthly attendance shall be certified by the designated officer (e.g., Senior most Officer of Administrative Cadre/ Head of Office) for release of remuneration. Absence without prior intimation may lead to termination.
Place of Duty	 Premises of ICAR-IIOR. May also be required to attend field units within the municipal limits of the same city, if necessary.
Job Description:	 Outdoor medical treatment of the regular employees & family members of the Institute. Consultation to regular Employees / RA / SRFs / Young professionals and students including who are not covered under ESIC benefits or other medical benefits Providing medical attention or health – related incident in emergent circumstances, without additional remuneration. Assistance in health advisor screening and awareness activities at the Institute during outbreaks/ epidemics/ pandemics Participation in internal health camps, vaccination drives or wellness initiatives organized by the institute

Other Terms & Conditions:

- 1. Eligible candidates are requested to submit duly filled in application in the specified format, along with self-attested copies of original certificates for educational qualifications, experience, publication list, age, social category etc. at the office by 10:30 AM on December 29, 2025. Following screening process, a list of shortlisted candidates will be called for a walk-in interview at 11:00 AM on the same day. The documents shall be verified at the time of joining. Any false declaration shall lead to termination.
- 2. No objection certificate (if employed) is also to be produced at the time of interview. The PTMO must declare if engaged in any other medical practice or consultancy elsewhere and must ensure that there is no conflict of interest.
- 3. No TA/DA is admissible for attending the interview and attending the duty or for any travel on selection.
- 4. The candidate must be medically fit and is required to submit a medical fitness certificate at the time of engagement.
- 5. In case of any legal dispute, the jurisdiction shall lie in the court of the city where the ICAR Institute is located.
- 6. The terms and conditions shall be governed as per the ICAR O.M. No. 3(4)/95-Per.IV dated 3rd December, 2025 and any further orders issued by the Council from time to time.
