6. The Officials of ICAR-IIOR and their family members are not eligible for participating in this bid.
7. The highest successful bidder fulfilling all the terms and conditions of the bid shall be awarded the sale order provided their bid is not less than the reserved price fixed by the Institute.
8. The successful bidder shall be required to lift all the material from the disposal site after payment of the full amount and receipt of approval from the office.
9. The highest bidders will have to deposit the entire amount, on the same day after weighing of the wood.
10. The highest bidder should ensure himself that the whole lot of wood that were weighed in presence of the vendor and decided as auctioned by this institute shall be lifted by the vendor on the same say day and in case any item left at site, the same shall be thrown away at the risk and cost of highest bidder.
11. No items once disposed to the highest bidder shall be taken back by ICAR-IIOR.
12. The labour, cartage and other expenses shall be borne by the highest bidder.
13. The terms and conditions are not exhaustive but general in ICAR-IIOR shall reserve the right to clarify any clause or part thereof the terms and conditions and that will be final and binding.
