Terms and conditions:-

- 1. Place of posting is ICAR-IIOR, Hyderabad. Work place may be at any place in Telangana.
- 2. The above position is purely temporary on contractual basis for a period of six months initially which is likely to be extended till the conclusion of the project, based on satisfactory performance of the incumbent, or until further orders whichever is earlier. There is no provision of re-engagement after termination of the project. The selected candidate shall not claim for regular appointment at this institute as the post is co-terminus with the project.
- 3. Age limit as on 01.08.2023: Minimum of 21 years and maximum age limit is 35 years for man and 40 years for women as per rules. Relaxation in upper age is permissible in case of SC/ST/OBC/PH candidates as per Govt. of India. Rules applicable to the external funded project.
- 4. No TA/DA and official accommodation will be provided for appearing in the walk in interview. Selected candidates have to make their own arrangement to stay at the place of work.
- 5. Candidates are requested to carry all original relevant documents / certificates along with set of attested photocopies. Photograph and duly filled in application form on the date of interview. They may attend the interview only if they fulfill the essential as well as the desired qualifications
