Eligible candidates are invited to attend a Walk-in-interview to fill up the purely temporary post of **Young Professional –I (One)** consolidated pay of Rs. 30,000.00 per month at Crop Protection section to be held on 28th JANUARY, 2026 at 11:00 AM at the ICAR-Indian Institute of Oilseeds Research, Rajendranagar, Hyderabad-500030.

Essential Qualifications:

- Graduate in Agriculture/Microbiology.

Desirable Experience:

- 1-2 years of experience in plant pathology lab and field experiments which includes isolation and maintenance of microbes, data collection in field experiments, knowledge in basic biotechnology experiments.

Nature of Work:

- It involves both lab oriented molecular research activities along with field experiments in addition to AICRP field experiments.

Age Limit:

- Minimum of 21 years and maximum of 45 years as on last date of application i.e 28.01.2026. Relaxation in upper age limit is permissible in case of SC/ST/OBC/PH candidates as per Govt. of India rules applicable to ICAR

Emoluments:

- Rs. 30,000/- per month consolidated. No HRA will be paid.
- The income tax or any other tax is liable to be deducted as per the prevailing rules will be deducted at the source before effecting payment of monthly salary.

Terms and conditions:-

1. The above position is purely on a contractual basis, time-bound and non – regular. Initial engagement of YP will be for one year which is extendable for two more years (01 year at a time) subject to requirement of the services of the YP and satisfactory performance of the candidate after evaluation. Thus the maximum duration of engagement of YP in the ICAR is three years. The selected candidate shall not claim for regular appointment at this Institute.
2. If the number of candidates reporting on the scheduled interview date exceeds ten (10), a written test will be conducted as part of the selection process. Based on the performance in the written test, shortlisted candidates will be called for the interview on the same day.
3. No TA/DA or stay will be provided for appearing in the Walk in Interview. After selection, candidates have to make their own arrangements for accommodation to stay at the place of work.
4. The initial place of posting would be ICAR-IIOR, Hyderabad but can be placed anywhere in India based on requirement.
5. Candidates are requested to carry all original relevant documents/caste certificates along with a set of attested on Xerox copies, photograph and duly filled in application form on the date of interview. They may attend the interview only if they fulfil the essential qualifications. Only relevant experience if any will be considered on producing the experience certificate. NOC from the previous employer should be produced if still working.
6. **Candidates have to report by 9:30 A.M. and register their candidature till 10.30 A.M. on 28.01.2026.**
7. The decision of the Director, IIOR, Hyderabad will be final and binding in all aspects.
